# RESEARCH INTERESTS

A primary focus of my program of research is how empathy and emotion shape, and are shaped by, our capacity to attend to suffering and to effectively work towards its relief.

The alleviation of world suffering requires action on the part of individuals. Yet, for these persons, awareness of and attention to suffering combined with a felt sense of connection may function as both assets and liabilities. While these capacities enable the galvanization necessary to incite actions aimed at the relief of suffering, they may come at powerful costs, undermining the well-being of advocates and the efficacy of their labors. Sustainable social change will require an awareness of the ways in which individual beliefs and behaviors, institutional policies, and cultural norms may hamper the alleviation of suffering
